## CLUB BOAT USER AGREEMENT

The Mark Sorensen Youth Sailing Program, hereafter referred to as “MSYSP”, allows the sailors participating in the youth programs to use MSYSP club boats. Each sailor will be assigned a boat with all the basic parts to go on the water safely. It is the sailor’s responsibility to report any damages to the boat to the coach, and the club will help with the upkeep of these boats. *If the damage is deemed by the coach to be deliberate or due to neglect, it is the parents’ and sailor’s responsibility to pay for the repairs.* We appreciate your cooperation in maintaining these boats, so that we can continue to provide a competitive fleet for our future sailors.

MSYSP provides basic club quality equipment. Parents are welcome to buy higher-end equipment upgrades such as sails to use in combination with club equipment. Each sailor will be assigned a numbered hull, dagger board, rudder, sail and associated fittings. The Parent and the Sailor agree to replace the broken or damaged parts in a timely manner, or assist with some or all of the costs of repairs to their assigned club boat. *The sailor may not use another club boat while theirs is being repaired.*

## AUTHORIZATIONS AND DISCLOSURES

I hereby authorize my child to participate in the Mark Sorensen Youth Sailing Program at the Upper Keys Sailing Club, hereafter referred to as “UKSC”. In consideration of MSYSP, a not for profit 501(c)3 Florida corporation, providing sailing instruction to my child, I hereby release, acquit and discharge MSYSP and UKSC, its successors and assigns, its employees, agents, members, volunteers, officers and directors from all claims, demands, actions, causes of action, damages, injuries and cost of any nature or kind whether property, personal or bodily injury or any other type of injury or damage that may arise from my child’s participation in the sailing program as well as use of the facilities of MSYSP/UKSC, and its equipment. This release is on my behalf as parent or legal guardian and on behalf of my child and any person claiming through my child.

I understand the risks inherent in the sport of sailing and in water sports in general, and in any activity involving children. I attest that my participating child has had swimming instructions and is capable of treading water for five minutes, swimming 25 meters with good form and easy breathing and demonstrates the capacity to alternate floating and treading water for an unlimited period of time. I understand that these skills may help reduce the risks but cannot eliminate them.

I also attest that my participating child is free and unencumbered from any physical or mental impairment and is free of any contagious or infectious disease that might interfere with his or her health or safety during this program.

## **Sailor Code of Conduct**

1. Children are restricted to the shaded youth area behind the Quonset hut and the patio and beach areas only.
2. No playing behind the clubhouse or on the main dock where the large sailboats are located.
3. No playing on or around private boats.
4. Access to the clubhouse is restricted to use of the bathrooms, use for changing when necessary and in case of bad weather.
5. Entry into the kitchen area is not permitted at any time.
6. Children are not allowed to sit at the bar or go behind the bar at any time.
7. No throwing of rocks, pebbles or pea rock.
8. No running on club property.
9. No bullying or “making fun” of other sailors will be tolerated and may result in immediate dismissal.
10. Curse words and bad language are not allowed.

## **Afloat**

1. Lifejackets must be worn at all times when sailing or swimming
2. Sailboats have no brakes so try to avoid collisions. Intentional ramming is not allowed and will result in instant dismissal.
3. Intentional flipping of any club boats is strictly prohibited as this may cause damage to any part of the boat and/or sail.
4. Please be respectful of all club property. Intentional flipping will result in immediate dismissal.

Bad behavior is disruptive, will not be tolerated and may result in time-out ashore or possible suspension of sailing privileges without refund of tuition fees.

## Parent Code of Conduct

The goal of MSYSP is to promote youth sailing as a fun and competitive sport; maintain the safety of all participants at all times; promote ethical behavior, and teach life-long lessons about character, teamwork, sportsmanship and respect for others. Participation in MSYSP is a privilege. The youth sailing program can only be successful if everyone - coaches, sailors and parents - work together in pursuit of these goals. MSYSP/UKSC has developed codes of conduct for coaches, parents and sailors so that everyone has common expectations. Parents of youth sailors are expected to behave according to the following guidelines:

- Parents provide support for their children and MSYSP. Parents essentially are partners with MSYSP in running the program, even if they are not members of UKSC. The program cannot function without the active engagement of parents.
- Assume responsibility for the safety of your children and other sailors.
- Follow all safety procedures and instructions given by coaches, race officials, regatta hosts and other responsible adults. Provide assistance if another person is in danger.
- Set a good personal example for everyone supporting the principles of honesty, integrity and sportsmanship.
- Treat sailors, coaches, club members, regatta officials, other parents, hosts and all others with respect, regardless of race, religion, gender, national origin, culture, sexual orientation or disabilities.
- Do not engage in verbal, physical or emotional abuse of anyone, and do not tolerate such conduct by others.
- Avoid the use of profane, insulting, harassing, humiliating or otherwise offensive language in the presence of sailors or coaches. Never use such language in communications with coaches. Mistreatment of coaches is grounds for removal of the program.
- Avoid excessive drinking of alcohol while at the club and at any MSYSP related activities and regattas.
- 
- Parents may not bring any outside alcohol onto UKSC property. Consumption of any outside alcohol on club grounds will lead to immediate dismissal. Parents can take advantage of the club's cash bar during regular club operating hours.

I hereby agree to the stipulations of this Parent Code of Conduct and agree to follow the set guidelines. I understand that if I do not do so, I risk being asked to leave the program and forfeit the associated program fees.
